

USPS Pricing Engine SDK

December 17, 2021

Summary

This is the Domestic and International Pricing Engine SDK (version 11.10.0.0) for the January 2022 Price Change Release. The following is a list of enhancements included in this release.

Updated databases

New databases have been created for this release: USPS_DOM_2022_01 and USPS_INTL_2022_01 for domestic and international respectively.

There are SKU Dictionary updates in this release. They need to be applied to the 2021_02 databases. They are located in the SKUDictionary folder. A batch file, sql_update_import.bat, has been provided to assist with their deployment. Execute the batch file by passing the targeted database. Note the batch file assumes the databases are LOCAL.

To execute and update your domestic and international databases:

sql_update_import.bat USPS_DOM_2022_01
```

```

Instructions

1. Copy the DLLs
2. Restore the databases (SQL Server 2016 backups). The database backups are not included and can be downloaded separately. Note: the SQL script files have been included in the package for those that cannot restore the SQL Server 2016 backups. SQL Scripts should be executed in the order shown below.

Note that scripts "CreateClient_PriceCalc_014X0.sql" and "CreateClient_CNS_008B3.sql" for domestic and "CreateClient_CNSv2_008B3.sql" for international must be executed on the 2021_01 and 2020_01 databases.
