## Summary

This is the Domestic and International Pricing Engine SDK (version 11.4.3.0) for the October 21, 2016 Release. The following is a list of Enhancements included in this release.

## Bug 7666 - International Retail and Business Calc - Revise GXG Insurance

 AmountIssue:
GXG has free insurance for the first $\$ 100$, regardless of whether additional insurance is purchased. If additional insurance is purchased, the first $\$ 100$ is still free, and the cost is $\$ 1.00$ for each additional $\$ 100$ (or fraction thereof) over $\$ 100$ (i.e. starting at $\$ 100.01$ ).

On the international retail calculator, and when the customer has selected GXG service; on the extra services page the insurance amount should state "From \$1.00" under both the "Retail" and CNS" columns. The calculation should be in $\$ 1.00$ increments starting a $\$ 100.01$ and for each $\$ 100$, or fraction thereof. Amounts of $\$ 100$ and under should reflect a zero insurance charge.

On the international business calculator, and when the customer has selected GXG service, and when clicking the extra services link; the calculation should be in $\$ 1.00$ increments starting a $\$ 100.01$ and for each $\$ 100$, or fraction thereof. Amounts of $\$ 100$ and under should reflect a zero insurance charge.
